Privacy policy

If there is a possibility to enter personal or business information on this website (e-mail addresses, names, addresses etc.), this information is disclosed by the user on an expressly voluntary basis. Use and payment of all services offered is permitted - in so far as technically possible and acceptable - even without disclosing such information or by disclosing anonymous information or using a pseudonym.

Your details are stored electronically. Naturally I observe the regulations of the Telemediengesetz (TMG = Telemedia Act) and the Bundesdatenschutzgesetz (BDSG = Federal Data Protection Act).

You are entitled at all times to free information, correction, blocking and deletion of your stored data (with the exception of data which I am obliged to save and store for legal reasons). Our contact details and an e-mail form are available at Contact.

However, until your customer account is deleted, you can make all necessary changes on your account page as long as you are logged in.

After subscribing to our newsletter, your email address is saved for advertising and market research purposes until you unsubscribe from the newsletter. I would like to draw your attention to the fact that you can withdraw your consent at any time with future effect.

Technical and organisational security measures are used to protect your recorded data against random or intentional manipulation, loss, destruction or access by unauthorised persons.

We point out that data transmission via the internet (e.g. communication by e-mail) may involve security flaws. Full protection of data against access by third parties is not possible.

I hereby declare that I will only record data for internal purposes (invoicing, shipping, reminders and customer information). This information will not be communicated to third parties at any time, apart from my service partners, who require data transfer to process orders (e.g. the shipping company entrusted with delivery and the bank in charge of payment transactions). In these cases, however, the scope of the data transferred is restricted to the necessary minimum only.

Use of the contact details published in accordance with the obligation to publish such details by third parties to send unsolicited advertising and information material is hereby expressly prohibited. The site operators expressly reserve the right to take legal action in the case of unsolicited sending of advertising information, for example via spam mails.

Cookies

Our Internet pages use so-called cookies at several points. These serve to make our offers more user-friendly, more efficient and more secure. Cookies are little text files that are stored on your computer and saved by your browser. Most of the cookies we use are so-called “session cookies”. These are automatically deleted after your visit. Cookies will not damage your computer and contain no viruses. We do not collect any personal data through cookies.

Google Analytics
